### **RECOMMENDATION**

It is recommended that the City Council adopt the resolution accepting a donation of \$10,000 from the Wilbur May Foundation for use by the Police Department's Drug Abuse Resistance Education (D.A.R.E.) program.

### **INTRODUCTION**

The Wilbur May Foundation has presented a donation to the City to facilitate purchases for the D.A.R.E. program.

### **DISCUSSION**

The Police Department's School Resource Officers provide drug awareness courses in the Beverly Hills Unified School District (BHUSD). In addition to providing officers to the BHUSD, the department is also the training center for D.A.R.E. officers throughout the state. The donation from the Wilbur May Foundation will be used to further train the department's School Resource Officers in the D.A.R.E. curriculum and facilitate purchases for the D.A.R.E. program.

**FISCAL IMPACT**

The City has received a donation of \$10,000 from the Wilbur May Foundation. Donated funds will be available for use by the Police Department's D.A.R.E. program in Fund 19 (1902202E016).

RESOLUTION OF THE COUNCIL OF THE CITY OF BEVERLY  
HILLS ACCEPTING A DONATION OF \$10,000 FROM THE WILBUR  
MAY FOUNDATION FOR THE D.A.R.E. PROGRAM

The Council of the City of Beverly Hills does hereby resolve as follows:

Section 1. The City has received a donation from the Wilbur May Foundation to be used for the Police Department's D.A.R.E. program.

Section 2. Pursuant to Government Code Sections 37354 and 37355, the City may accept such gift and may put such gift to such uses as the City Council prescribes.

Section 3. The City Council hereby accepts the donation for use by the Police Department's D.A.R.E. Program.

Section 4. Donated funds will be available for use by the Police Department's D.A.R.E. program in Fund 19 (1902202E016).

Section 5. The City hereby appoints the City Manager or his designee as agent of the City of Beverly Hills to accept the donated funding and to execute and submit all documents including, but not limited to purchase orders and payment requests, which may be necessary for acquisition for the D.A.R.E. Program.

Section 6. The City Clerk shall certify to the adoption of the Resolution and shall cause the Resolution and his certification to be entered in the Book of Resolutions of the Council of the City.
