RECOMMENDATION

Staff recommends that City Council accept donations from the City of Beverly Hills Community Charitable Foundation (CBHCCF) in the amount of \$192,640 received in support of the City of Beverly Hills Community Dog Park project. The funds have been accepted by the CBHCCF, and upon acceptance by the City would be transferred from the CBHCCF account to the City account and appropriated for the Dog Park Construction as follows:

INTRODUCTION

This report provides information in regards to City donations that were received specifically for the Beverly Hills Community Dog Park project and have been accepted by the CBHCCF in the amount of \$192,640. Staff seeks City Council approval to appropriate the entire \$192,640 to the Beverly Hills Community Dog Park Capital Improvement Project (CIP) Account.

DISCUSSION

The CBHCCF has approved and accepted the donations totaling \$192,440 at its June 29, 2016 Board meeting and \$200 at a previous Board meeting. These donations are from various members of the community, including a very generous donation from Councilmember Bosse and were specifically designated for support of the Beverly Hills Community Dog Park. The funds will also be used to provide additional enhancements to the Dog Park which were not part of the "Base Model" including additional trees, benches, and drinking fountains.

FISCAL IMPACT

The receipt and approval of this \$192,640 donation will assist to defray costs associated with the \$600,000 CIP budget for the Beverly Hills Community Dog Park set to open later this summer in 2016.
