The following report is provided to the Human Relations Commission as an information item.

INTRODUCTION

At the January 20, 2011 Human Relations Commission meeting during *Comments by Commissioners Including Topics for Future Agendas*, a request was made to develop a tool for tracking the Commission's work. The report gives a brief overview of the current and pending agenda items and provides a calendar for upcoming items.

BACKGROUND

The Commission plays an important role in extending the reach of democracy into the community. As the eyes and ears of the community, the Commission examines issues of concern within the scope of their mission and discusses them in depth at meetings where public input is encouraged. As an advisory body to City Council, the Human Relations Commission responsibilities are as follows:

- Advises, recommends, assists and encourages activities that promote positive human relations in all aspects of community life
- Actively promotes a just and equitable multi-cultural society
- Endeavors to reduce conflict and tension, as well as discrimination, prejudice and stereotyping based on race, religion, gender, sexual orientation, national origin, age, disability, or any other arbitrary factor
- Defining, identifying and tracking existing and emerging issues that may benefit from intervention or conflict resolution
- Receiving citizen complaints, in an appropriate time and manner, concerning the interactions of City employees with the public.

Issues and items for Commission consideration may be generated through many sources including the public, the Commission representatives (BHUSD, BHPD), the staff, the Commission, its ad hoc committees, Council liaisons and by direction or action of City Council. At Commission meetings, information is generally conveyed to the Commission through presentations, public comment, staff reports, information included in commission packets and comments made by commissioners and staff. These types of communications between the Commission, the public, staff and the City Council enable the Commission to fulfill its mission.

DISCUSSION

At the Commission's request, staff prepared a recurring agenda item to give each member the opportunity to review past, current and upcoming agenda items. It can be challenging to track the Commission's work when meeting just monthly. The Commission minutes offer continuity from meeting to meeting, but do not always provide a complete picture of the Commission's work in progress. The tentative list of upcoming Commission agenda items includes; active, pending, yearly agenda items and a list of motions since October 2011.

This information gives members of the Commission a more comprehensive view of current and upcoming agenda items. Due to the interactive nature of municipal government, scheduling dates of agenda items and the topics to be presented are subject to change. ***Please note that items that have recently been added to the list are in bold italics.***

FISCAL IMPACT

There is no fiscal impact associated with the discussion of this Agenda Item.

RECOMMENDATIONS

Staff recommends that prior to each meeting, Commissioners review the list of upcoming agenda items to be considered and make comments, if any, during the Commission meeting.
