



**CITY CLERK'S CERTIFICATION THAT
THERE ARE SUFFICIENT SIGNATURES
ON AN INITIATIVE PETITION**

I, Byron Pope, City Clerk of the City of Beverly Hills, do hereby certify pursuant to Section 9240 of the Elections Code of the State of California, to the following facts relating to An Initiative Measure Requiring The City to Provide Free Parking for Two Hours at Particular City-Owned Parking Facilities and Limiting the Amount of Monthly Parking at Those Facilities.

On September 14, 2010, an Initiative Petition was filed with the City Clerk's Office of the City of Beverly Hills by Adam Englander representing Marcia Caden. Further, on September 14, 2010, the County of Los Angeles, Registrar-Recorder's Office confirmed to the Secretary of State that there are 20,919 registered voters in the City of Beverly Hills. The petition must have a minimum of 2,092 signatures (10% of the registered voters in the City) to qualify for filing. The petition was circulated for signatures between the period August 17, 2010 and September 14, 2010.

Pursuant to Section 9240 of the Elections Code of the State of California, the Los Angeles County Registrar-Recorder, at the request of the Beverly Hills City Clerk, examined the petition and determined that the petition is signed by not less than 10 percent of the registered voters of the City. Based on the County of Los Angeles Registrar of Voters' Signature Verification Certificate, attached hereto, I have determined the following facts regarding this petition:
