### INTRODUCTION

The Charitable Solicitations Commission Interview Panel composed of Vice Mayor John Mirisch, Councilmember Julian A. Gold, MD, Charitable Solicitations Commission Chair Lillian Raffel and Charitable Solicitations Commissioner Jan Block met on Monday evening, May 14, 2012. The panel interviewed twelve candidates for one upcoming vacancy on the Commission. One additional applicant withdrew from the process prior to the interview date.

### DISCUSSION

After discussion and careful review, the majority of the Panel recommended **Murray D. Fischer** for appointment. Vice Mayor Mirisch was not in agreement with this choice voicing concern with the frequent lobbying activities in front of many elected and appointed bodies in the City by this applicant. The registered legislative advocate forms for this applicant on file with the City are attached to this report per Vice Mayor Mirisch's direction. The Panel agreed on **Richard Schreiber** as a 2<sup>nd</sup> choice for appointment, however the panel majority would prefer to appoint their 1<sup>st</sup> choice.

### RECOMMENDATION

The Charitable Solicitations Commission Interview Panel seeks City Council approval. With the concurrence of the Council, a formal report will be prepared for adoption for the appointment of the preferred appointee on the June 19, 2012 Regular City Council meeting.

In addition, the Panel requests that the remaining candidates be thanked and advised that they each gave thoughtful and compelling answers to the questions posed by the Panel. The City is fortunate to have an exceptionally strong applicant pool and the applicants are encouraged to re-apply and attend as many future Charitable Solicitations Commission meetings as possible. In addition, those applicants who have not participated in Team Beverly Hills are urged to do so.
