Subject: APPROVAL OF AN AGREEMENT BETWEEN THE CITY OF BEVERLY HILLS AND NATIONAL URBAN FELLOWS, INC. FOR A CLASS OF 2015 FELLOW; AND APPROVAL OF A PURCHASE ORDER IN A NOT-TO-EXCEED AMOUNT OF \$70,000.00 TO NATIONAL URBAN FELLOWS, INC. FOR THESE SERVICES.

RECOMMENDATION

It is recommended that the City Council approve the agreement between the City of Beverly Hills and National Urban Fellows, Inc. for a Class of 2015 Fellow and approve a purchase order in a not-to-exceed amount of \$70,000.00 for these services.

INTRODUCTION

For the past four years, the City has contracted with National Urban Fellows, Inc. ("NUF") for a fellow to provide professional level staff support on significant projects for the City. In 2010, Troy Bell was selected as the City's fellow, he worked on several significant projects including the creation of a long-range financial revenue and expenditure forecast model. Troy completed his nine-month fellowship with the City on May 20, 2011.

In 2011, Angie Molina was selected as the City's National Urban Fellow. Angie provided staff support to the Small Business Task Force chaired by Councilmember Gold, assisted with the development of a final report of the Task Force's findings and recommendations, and presented to the City Council on March 6, 2012. Angie also developed a Comparative Cost of Doing Business Report, which compares tax rates in Beverly Hills to those of neighboring cities. Angie completed her fellowship on May 25, 2012.

In 2012, Wendy K. Hughes was selected as the City's National Urban Fellow. Wendy facilitated the creation of the first ever City of Beverly Hills Homeland Security and Disaster Strategic plan. The 31-page detailed plan was developed to help the City establish priorities, make informed decisions and drive future grant and Department of Homeland Security (DHS) special projects. The plan includes strategic goals, city-wide and departmental priorities along with key group decisions around criteria which future projects are measured against. She also worked with the Community Services Human Services Administrator and Outreach Manager to develop a public awareness campaign '*Positive Change, Not Spare Change*' around the growing panhandling situation in Beverly Hills. Wendy researched and created an iPad implementation plan for the Beverly Hills Unified School District. She also began a business stakeholder outreach program with the local hotels on behalf of the City's Office of Emergency Management Director.

In 2013, Adrienne Irmer was selected to evaluate the city's in-lieu parking program, and is currently working with city staff to develop recommendations on the potential expansion of this program to new commercial areas within the city, and reviewing fees and payment structure to determine the cost and feasibility of constructing public parking in studied areas. She also completed research relating to e-cigarettes and smoking when the Health & Safety Commission was tasked with reviewing this issue and to develop a policy recommendation. Adrienne will also be involved with projects and programs relating to the incoming Mayor's initiatives. She will complete her 9-month fellowship on May 23, 2014.

For the 2014-2015 fiscal year, the City has another opportunity to retain a fellow through NUF to provide professional support for significant projects within the organization. Attached in the Work Plan Exhibit are examples of various projects the fellow will have the opportunity to take part in. These projects will contribute substantially to the learning experience for the fellow, and to the objectives of the organization. As in the prior four NUF fellowships, the fellow will not be employed by the City, however, the City will provide a workspace and administrative support. The City's only financial responsibility will be to NUF corporate and other miscellaneous training expenses.

DISCUSSION

As an organization, NUF promotes diverse leadership at the top levels of public service organizations. For 45 years, NUF has identified, recruited and developed the best and brightest multi-ethnic, multi-cultural and mid-career women and men who have the potential to make a significant impact on public policy and administration by identifying issues, shaping solutions and developing policies.

Each year NUF awards 35-40 fellowships to deserving mid-career professionals eager to transition into leadership positions. Over a period of 14 months, fellows complete a Master of Public Administration academic program at the School of Public Affairs at Bernard M. Baruch College (an accredited MPA program) which is part of the University of New York. As part of the program, fellows work closely with a mentor during a nine-month internship to develop professional, competent leadership skills, as well as establish a network with NUF alumni and the mentor's organization.

FISCAL IMPACT

The cost for a Class of 2015 fellow is \$70,000. This payment covers the fellow's stipend, fees, books, health coverage, NUF program travel and moving expenses. Funds for the cost of the agreement with National Urban Fellows, Inc., are included in the current FY13-14 Policy and Management department budget for the first payment installment, and funds will be included in the Policy and Management department's FY14-15 budget for the second payment installment.

AGREEMENT BETWEEN THE CITY OF BEVERLY
HILLS AND NATIONAL URBAN FELLOWS, INC. FOR A
CLASS OF 2015 FELLOW.

THIS AGREEMENT is made by and between the City of Beverly Hills (hereinafter called "CITY"), and National Urban Fellows, Inc. (hereinafter called "CONTRACTOR").

RECITALS

A. CITY desires to have certain services and/or goods provided as set forth in Exhibit A (the "Scope of Work"), attached hereto and incorporated herein.

B. CONTRACTOR represents that it is qualified and able to perform the Scope of Works.

NOW, THEREFORE, the parties agree as follows:

Section 1. CONTRACTOR's Scope of Work. CONTRACTOR shall perform the Scope of Work described in Exhibit A in a manner satisfactory to CITY and consistent with that level of care and skill ordinarily exercised by members of the profession currently practicing in the same locality under similar conditions. City shall have the right to order, in writing, changes in the Scope of Work. Any changes in the Scope of Work by CONTRACTOR must be made in writing and approved by both parties. The cost of any change in the Scope of Work must be agreed to by both parties in writing.

Section 2. Time of Performance. CONTRACTOR shall commence its services under this Agreement upon receipt of a written notice to proceed from CITY. CONTRACTOR shall complete the performance of services by the Termination Date set forth above and/or in conformance with the project timeline established by the City Manager or his designee.

The City Manager or his designee may extend the time of performance in writing for two additional one-year terms or such other term not to exceed two years from the date of termination pursuant to the same terms and conditions of this Agreement.

Section 3. Compensation.

(a) Compensation. CITY agrees to compensate CONTRACTOR for the services and/or goods provides under this Agreement, and CONTRACTOR agrees to accept in full satisfaction for such services, a sum not to exceed the Consideration set forth above and more particularly described in Exhibit B, attached hereto and incorporated herein.

(b) Expenses. The amount set forth in paragraph (a) shall include reimbursement for all actual and necessary expenditures reasonably incurred in the performance of this Agreement (including, but not limited to, all labor, materials, delivery, tax, assembly, and installation, as applicable). There shall be no claims for additional compensation for reimbursable expenses.

(c) Additional Services. CITY may from time to time require CONTRACTOR to perform additional services not included in the Scope of Services. Such requests for additional services shall be made by CITY in writing and agreed upon by both parties in writing.

Section 4. Method of Payment. Unless otherwise provided for herein, CONTRACTOR shall submit to CITY a detailed invoice, on a monthly basis or less frequently, for the services performed pursuant to this Agreement. Each invoice shall itemize the services rendered during the billing period and the amount due. Within 30 days of receipt of each invoice, CITY shall pay all undisputed amounts included on the invoice. CITY shall pay CONTRACTOR said Consideration in accordance with the schedule of payment set forth in Exhibit B, attached hereto and incorporated herein.

Section 5. Independent Contractor. CONTRACTOR is and shall at all times remain, as to CITY, a wholly independent contractor. Neither CITY nor any of its agents shall have control over the conduct of CONTRACTOR or any of CONTRACTOR's employees, except as herein set forth. CONTRACTOR shall not, at any time, or in any manner, represent that it or any of its agents or employees are in any manner agents or employees of CITY.

Section 6. Assignment. This Agreement shall not be assigned in whole or in part, by CONTRACTOR without the prior written approval of CITY. Any attempt by CONTRACTOR to so assign this Agreement or any rights, duties or obligations arising hereunder shall be void and of no effect.

Section 7. Responsible Principal(s).

(a) CONTRACTOR's Responsible Principal set forth above shall be principally responsible for CONTRACTOR's obligations under this Agreement and shall serve as principal liaison between CITY and CONTRACTOR. Designation of another Responsible Principal by CONTRACTOR shall not be made without prior written consent of CITY.

(b) CITY's Responsible Principal shall be the City Manager or his designee set forth above who shall administer the terms of the Agreement on behalf of CITY.

Section 8. Personnel. CONTRACTOR represents that it has, or shall secure at its own expense, all personnel required to perform CONTRACTOR's Scope of Work under this Agreement. All personnel engaged in the work shall be qualified to perform such Scope of Work.

Section 9. Permits and Licenses. CONTRACTOR shall obtain and maintain during the Agreement term all necessary licenses, permits and certificates required by law for the provision of services under this Agreement, including a business license.

Section 10. Interests of CONTRACTOR. CONTRACTOR affirms that it presently has no interest and shall not have any interest, direct or indirect, which would conflict in any manner with the performance of the Scope of Work contemplated by this Agreement. No person having any such interest shall be employed by or be associated with CONTRACTOR.

Section 11. Insurance.

(a) CONTRACTOR shall at all times during the term of this Agreement carry, maintain, and keep in full force and effect, insurance as follows:

(1) A policy or policies of Comprehensive General Liability Insurance, with minimum limits of One Million Dollars (\$1,000,000) for each occurrence, combined single limit, against any personal injury, death, loss or damage resulting from the wrongful or negligent acts by CONTRACTOR.

(2) A policy or policies of Vehicle Liability Insurance covering any vehicle utilized by CONTRACTOR in performing the Scope of Work required by this Agreement with minimum limits as required by State law to insure against personal injury and property damage.

(3) Workers' compensation insurance as required by the State of California.

(b) CONTRACTOR shall require each of its sub-contractors to maintain insurance coverage which meets all of the requirements of this Agreement.

(c) The policy or policies required by this Agreement shall be issued by an insurer admitted in the State of California and with a rating of at least a B+;VII in the latest edition of Best's Insurance Guide.

(d) CONTRACTOR agrees that if it does not keep the aforesaid insurance in full force and effect CITY may either immediately terminate this Agreement or, if insurance is available at a reasonable cost, CITY may take out the necessary insurance and pay, at CONTRACTOR's expense, the premium thereon.

(e) At all times during the term of this Agreement, CONTRACTOR shall maintain on file with the City Clerk a certificate or certificates of insurance on the form set forth in Exhibit C, attached hereto and incorporated herein, showing that the aforesaid policies are in effect in the required amounts. CONTRACTOR shall, prior to commencement of work under this Agreement, file with the City Clerk such certificate or certificates. The general and auto liability insurance shall contain an endorsement naming the CITY as an additional insured. All of the policies required under this Agreement shall contain an endorsement providing that the policies cannot be canceled or reduced except on thirty (30) days prior written notice to CITY, and specifically stating that the coverage contained in the policies affords insurance pursuant to the terms and conditions as set forth in this Agreement.

(f) The insurance provided by CONTRACTOR shall be primary to any coverage available to CITY. The policies of insurance required by this Agreement shall include provisions for waiver of subrogation.

(g) Any deductibles or self-insured retentions must be declared to and approved by CITY. At the option of CITY, CONTRACTOR shall either reduce or eliminate the deductibles or self-insured retentions with respect to CITY, or CONTRACTOR shall procure a bond guaranteeing payment of losses and expenses.

Section 12. Indemnification. CONTRACTOR agrees to indemnify, hold harmless and defend CITY, City Council and each member thereof, and every officer, employee and agent of CITY, from any claim, liability or financial loss (including, without limitation, attorneys fees and costs) arising from any intentional, reckless, negligent, or otherwise wrongful acts, errors or omissions of CONTRACTOR or any person employed by CONTRACTOR in the performance of this Agreement.

Section 13. Termination.

(a) CITY shall have the right to terminate this Agreement for any reason or for no reason upon five calendar days' written notice to CONTRACTOR. CONTRACTOR agrees to cease all work under this Agreement on or before the effective date of such notice.

(b) In the event of termination or cancellation of this Agreement by CITY, due to no fault or failure of performance by CONTRACTOR, CONTRACTOR shall be paid based on the percentage of work satisfactorily performed at the time of termination. In no event shall CONTRACTOR be entitled to receive more than the amount that would be paid to CONTRACTOR for the full performance of the services required by this Agreement. CONTRACTOR shall have no other claim against CITY by reason of such termination, including any claim for compensation.

Section 14. CITY's Responsibility. CITY shall provide CONTRACTOR with all pertinent data, documents, and other requested information as is available for the proper performance of CONTRACTOR's Scope of Work.

Section 15. Information and Documents. All data, information, documents and drawings prepared for CITY and required to be furnished to CITY in connection with this Agreement shall become the property of CITY, and CITY may use all or any portion of the work submitted by CONTRACTOR and compensated by CITY pursuant to this Agreement as CITY deems appropriate.

Section 16. Records and Inspections. CONTRACTOR shall maintain full and accurate records with respect to all matters covered under this Agreement for a period of 2 years. City shall have access, without charge, during normal business hours to such records, and the right to examine and audit the same and to make copies and transcripts therefrom, and to inspect all program data, documents, proceedings and activities.

Section 17. Changes in the Scope of Work. The CITY shall have the right to order, in writing, changes in the scope of work or the services to be performed. Any changes in the scope of work requested by CONTRACTOR must be made in writing and approved by both parties.

Section 18. Notice. Any notices, bills, invoices, etc. required by this Agreement shall be deemed received on (a) the day of delivery if delivered by hand during the receiving party's regular business hours or by facsimile before or during the receiving party's regular business hours; or (b) on the second business day following deposit in the United States mail, postage prepaid to the addresses set forth above, or to such other addresses as the parties may, from time to time, designate in writing pursuant to this section.

Section 19. Attorney's Fees. In the event that either party commences any legal action or proceeding to enforce or interpret the provisions of this Agreement, the prevailing party in such action shall be entitled to reasonable attorney's fees, costs and necessary disbursements, in addition to such other relief as may be sought and awarded.

Section 20. Entire Agreement. This Agreement represents the entire integrated agreement between CITY and CONTRACTOR, and supersedes all prior negotiations, representations or agreements, either written or oral. This Agreement may be amended only by a written instrument signed by both CITY and CONTRACTOR.

Section 21. Exhibits; Precedence. All documents referenced as exhibits in this Agreement are hereby incorporated in this Agreement. In the event of any material discrepancy between the express provisions of this Agreement and the provisions of any document incorporated herein by reference, the provisions of this Agreement shall prevail.

Section 22. Governing Law. The interpretation and implementation of this Agreement shall be governed by the domestic law of the State of California.

Section 23. City Not Obligated to Third Parties. CITY shall not be obligated or liable under this Agreement to any party other than CONTRACTOR.

Section 24. Severability. Invalidation of any provision contained herein or the application thereof to any person or entity by judgment or court order shall in no way affect any of the other covenants, conditions, restrictions, or provisions hereof, or the application thereof to any other person or entity, and the same shall remain in full force and effect.

EXHIBIT A

SCOPE OF WORK

CONTRACTOR shall provide a 2015 National Urban Fellow ("Fellow") to CITY through the City Manager. The Fellow will complete an internship with CITY commencing September 2, 2014 and concluding May 22, 2015. During the internship, the Fellow will be assigned and shall complete projects of significance and impact to CITY.

The City Manager will serve as the Fellow's Mentor and will document and evaluate the internship experience, the Fellow's performance, and technical and managerial competencies. The City Manager will meet with the Fellow at least once a month for review, planning, and evaluation and will provide advice and assistance in career planning and development.

A designated CITY staff member will serve as the Liaison and will coordinate the Fellow's orientation program, including introducing the Fellow to key contacts in CITY departments. The Liaison will assist the Mentor with communicating expectations regarding assignments.

The Fellow will have a designated workspace in the Policy and Management Department that includes a desk, computer workstation, telephone, and file storage space. The Fellow will also be provided workspace in various CITY departments depending on projects assigned. The Fellow will be provided a CITY email address and will have access to a fax and copy machine.

EXHIBIT B

SCHEDULE OF PAYMENT AND RATES

CITY shall compensate CONTRACTOR a total payment not to exceed Seventy Thousand Dollars (\$70,000.00) for the assignment of the Fellow for the period of September 2, 2014 through May 22, 2015. This payment covers the Fellow's stipend, fees, books, health coverage, Fellow program travel and moving expenses.

CONTRACTOR shall submit an itemized statement to CITY for services as outlined in Exhibit A, which shall include documentation setting forth in detail a description of the services to be performed. CITY shall pay CONTRACTOR the amount of such billing within thirty (30) days of receipt of same.

Project Name: Disaster Business Certification Program and Stakeholder Outreach

Project:

Assist the Director of Emergency Management with the development and outreach relating to the disaster business certification program and related stakeholder outreach.

Competencies & Skills:

- Good project management and organizational skills
- Ability to work with businesses and other stakeholders such as Faith Based Organizations and Community Based Organizations
- Ability to research current programs and develop concise summaries and present findings
- Ability to implement a program
- Ability to make presentations
- Conduct outreach and create “buy-in” to the project
- Ability to work independently
- Self-starter who enjoys completing projects from start to finish

Mentor techniques & Fellow Activities:

Under direction of the Director of Emergency Management, develop and implement a disaster certification program for businesses and other stakeholders. This program will help organizations with preparing their employees, businesses, services, and facilities for emergencies and disasters. The program should provide a framework to assist businesses in preparing for, responding to, and recovering from a disaster. The Fellow will develop MOU's between the City and stakeholders.

- Collaborative and collegial style as a team leader with internal and external colleagues and stakeholders.

- Ability to prepare and deliver effective presentations.

Mentor Techniques & Fellow Activities:

Work with the City Manager, Assistant City Manager and City staff to implement a community visioning and strategic planning process. The end product of this process is to develop a five to ten year plan for prioritizing resource allocations, programs and service delivery aligned with the City's vision statement(s). The project will entail reaching out to citizens not usually heard from and determine what the community would like the city to look like in five, ten, and twenty years.

This project will require research and becoming familiarized with existing "healthy living" programs that are ongoing in other cities and counties. Fellow will be involved with community outreach, coordination with various departments and stakeholders, as well as research to determine best strategies to

carry out concurrent programs and activities for residents and businesses.

Timeline: September 2014 – May 2015 (5-10 hours/week)

Project Name: *Develop a knowledge base of City departments, policies and procedures*

A key component to understanding the way that local government works is to develop a clear knowledge of the various roles and responsibilities within the Policy and Management department.

Project:

Although this is not a project that will provide a specific end product, the purpose of this project is to underline the importance of participating in various department meetings such as: Department Head meeting, Agenda Review meetings, City Council Meetings, Liaison/Ad Hoc meetings, etc. to become as familiar as possible with the various planning processes and projects that are taking place within the City Manager's office and that of Policy and Management. Observing various departments and meeting with department heads or senior staff increases exposure to and participation in all city and local government activities.

Competencies & Skills:

- Develop a knowledgebase of City departments, policies and procedures.
- Collaborative and collegial style as a team leader with internal and external colleagues and stakeholders.
- Ability to multi-task and communicate effectively both orally and in writing with staff, elected officials and members of the community.

Mentor techniques & Fellow Activities: Working directly with mentor, liaison and staff to observe and learn the various roles and responsibilities that take place in a city government.
