### **RECOMMENDATION**

Staff recommends that the City Council approve the purchase of SWAT Tactical Vests from Aardvark Tactical for the amount of \$99,996.60.

### **INTRODUCTION**

SWAT officers operate in a high-risk environment. The potential for an armed confrontation is elevated above the daily risks associated with law enforcement work. Due to the risks involved in SWAT operations, special vests have been developed to provide a higher level of protection.

### **DISCUSSION**

The current vests have reached the end of their life cycle and must be replaced. This purchase would replace the outdated SWAT Tactical Vests currently in use by the SWAT Team.

### **FISCAL IMPACT**

The costs associated with this purchase total \$99,996.60. These items will be purchased with equipment replacement funds. These funds have already been allocated for FY


15/16. There will be a replacement cost that will also be covered by Fund 400 when the vests reach the end of their life cycle.
