### **RECOMMENDATION**

It is recommended that the City Council adopt the resolution accepting a donation of \$2,000 from Frank and Judy Fenton and appropriate funds in the amount of \$2,000 for purchase of a Police Patrol bicycle.

### **INTRODUCTION**

It is requested that the City Council adopt a resolution accepting the donated funding from Frank and Judy Fenton and appropriate \$2,000 to fund the purchase of this public safety equipment.

### **DISCUSSION**


The Bicycle Unit of the Police Field Services Division, Patrol Bureau, is being revitalized to deal with quality of life issues impacting the Community, such as with the Homeless Outreach program. To immediately meet this task, the Police Department has trained approximately 20 additional officers in bicycle patrol techniques with in-house instructors. These officers will be collaterally deployed as necessary in teams. This additional bicycle will replace equipment that has had eight to ten years of service and will be used by the Patrol Bicycle officers.

RESOLUTION OF THE COUNCIL OF THE CITY OF BEVERLY HILLS ACCEPTING A DONATION OF \$2,000 FROM FRANK AND JUDY FENTON FOR A POLICE BICYCLE AND APPROPRIATING FUNDS FOR PURCHASE OF THIS EQUIPMENT

The Council of the City of Beverly Hills does hereby resolve as follows:

Section 1. The City has received a donation from Frank and Judy Fenton for the purchase of an addition to the bicycle fleet, for the Police Patrol Bureau.

Section 2. The donated funding is in the amount of \$2,000 and will be deposited to the City General Fund.

Section 3. Appropriation of funds in the amount of \$2,000 is authorized as follows:

Section 5. The City Clerk shall certify to the adoption of the Resolution and shall cause the Resolution and his certification to be entered in the Book of Resolutions of the Council of the City.




