DISCUSSION


The acceptance of this donation will allow the Police Department to expand their bicycle patrol program.

RESOLUTION OF THE COUNCIL OF THE CITY OF BEVERLY HILLS ACCEPTING A DONATION OF \$500 FROM COUNCILMEMBER LINDA BRISKMAN AND GARY BRISKMAN FOR A POLICE BICYCLE AND APPROPRIATING FUNDS FOR PURCHASE OF THIS EQUIPMENT

The Council of the City of Beverly Hills does hereby resolve as follows:

Section 1. Councilmember Linda Briskman and Gary Briskman have offered the City a donation of \$500 for the purchase of one fully equipped bicycle for the Police Patrol Bureau.

Section 2. Pursuant to Government Code Sections 37354 and 37355, the City may accept such gift and may put such gift to such uses as the City Council prescribes.

Section 3. The City Council hereby accepts the donation for the purchase of a bicycle for the Police Patrol Bureau from the Beverly Hills Rotary Community Foundation.

Section 4. Appropriation of funds in the amount of \$500 is authorized as follows:

Section 5. The City hereby appoints the City Manager or his designee as agent of the City of Beverly Hills to accept the donated funding and to execute and submit all documents including, but not limited to purchase orders and payment requests, which may be necessary for acquisition of this equipment.

Section 6. The City Clerk shall certify to the adoption of the Resolution and shall cause the Resolution and his certification to be entered in the Book of Resolutions of the Council of the City.


