SUBJECT: Updated 2011 Halloween Enforcement Report

On October 31, 2011 the Beverly Hills Parking Enforcement Division conducted a special task force for Halloween which was located in the northern part of the city bordering the west boundary of the City of West Hollywood.

The enforcement was to alleviate additional congestion of vehicles parking in the residential neighborhoods of Beverly Hills from the West Hollywood Halloween Party approved by the City of West Hollywood.

Prior to the enforcement, 72 hours, parking signs were posted indicating No Parking in the selected blocks of the northern part of the city to advise residents and visitors of the restrictions. (see enclosed parking map).

Additional recommendations of residential streets to be included in the enforcement area are streets detailed in the enclosed memo.


The special event parking citation, 7-1-5B of the Beverly Hills Municipal Code, was approved by the Beverly Hills Chief of Police.

Mailings were sent out to all residential homes with a letter indicating the restrictions and 3 temporary parking permits. There were an additional 239 permits requested by residents in the area.

The enforcement began at 4:00 pm and extended to 2:30 am of October 31, 2011 to Nov. 1, 2011 and employed an additional eleven parking officers to accomplish the task issuing 164 citations.

SUBJECT: 2011 Halloween Enforcement Posted Signs

The following is a recommendation for additional streets to be included in the Halloween Enforcement Map Area.

- 1) North Maple Dr. from Carmelita Ave. to Elevado Ave.
- 2) North Palm Dr. from Carmelita Ave. to Sunset Blvd.
- 3) North Hillcrest Rd. from Carmelita Ave. to Sunset Blvd.
- 4) North Arden Dr. from Carmelita Ave. to Sunset Blvd.
- 5) North Alta Dr. from Elevado Ave. to Sunset Blvd.
- 6) Elevado Ave. from North Maple Dr. to North Sierra Dr.
